ABOUT THE POLISH OMBUDSMAN

The Ombudsman, officially named Commissioner for Human Rights (CHR), is the constitutional authority for legal control and protection and the national institution for human rights. The key function of the CHR is to safeguard human civic freedoms and rights in Poland, and to ensure that the public authorities respect democratic and human rights standards. The CHR has offices in Polish four cities, and in 2017 the office received a total of 52836 complaints, 25711 were handled. The Ombudsman's activities are independent from the state authorities, and acts pursuant to Poland's Costitution and the Commisioner for Human Rights Act of 15 July 1988. The CHR is elected by Sejm every 5th year, and the candidate has to be accepted by the Senate. Adam Bodnar is Poland's 7th Ombudsman, and took office September 9th 2015, after Irena Lipowicz.
